

CONTRACT MODELS FUTURCAM.COM

On the one hand, **FUTURTECNOLOGIAS AVANZADAS SLU** with tax identification number B76737345 and registered office in C/Aguere 9, 1-18 Santa Cruz de Tenerife 38005, España, hereinafter referred to as "**FUTURTECNOLOGIAS**".

On the other hand, the artist, understood as such any person interested in broadcasting via webcam with the support of the technical means provided by **FUTURTECNOLOGIAS**. In the future, "**the artist**".

GENERAL PROVISIONS

1. LEGAL AGE FOR RECORDING AND TRANSMISSION

The artist declares that at the time of your registration with **FUTURTECNOLOGIAS**, complies with the requirements of the age of majority in your country of residence, and in your case, it will never be less than 18 years, the minimum legal age to transmit. (21 years in some regions)

2. THE LEGAL FORM OF THE RELATIONSHIP

The artist will not be regarded in any case worker for the purposes of employment. The legal relationship with **FUTURTECNOLOGIAS** shall be governed in all cases by the labor laws of each country, taking into account the nature Free-lancer for the activity.

The artist expressly declares, that is not subject to the guidelines of the web site address, at work. Nor received a schedule, being totally free the provision of the service.

3. REGISTRATION DOCUMENTATION

For the registration in the platform of **FUTURTECNOLOGIAS**, the artist should provide sufficient evidence for the verification of the stipulation first.

The minimum documentation to provide:

- **Both sides of the identity document to color**, which shall contain, at a minimum: photo, name and surname, document number, date of birth and country of residence.
- **Photo of the face holding his identity document (document verification)**. So that you can verify that the submitted document corresponds to the person who will transmit.
- **Other documents of verification**. In case of doubt on the part of the verification team, the identity or age of majority of the model. You can request additional form of another additional identity document, such as: passport or driving license of the artist.

The artist declares that in no case will provide data or documents of a third person at the high of your personal account.

Will be the basis of **partial rejection** of the high on the platform:

- Identity documents with poor quality.
- Identity documents with doubts about its veracity.
- Verification document is illegible or poor quality.

Reasons for rejection will be total and definitive on the platform:

- Falsification of the document of identity, in order to cover up the real age of the artist.
- Modification of any data, through programs prepared for it, in order to carry out error to FUTURTECNOLOGIAS in the verification of the data.
- Sending a document of identity that does not belong to the artist that are shown in the photos.

4. PHOTOS OF THE ARTIST TO PROFILE.

The artist must provide 6 photos in the registration process. The photos must be of excellent quality with a **minimum mpX 1024 x 768**.

The photos will be free to use on the part of the platform, giving the model explicitly the rights on the photos, to:

- The platform for advertising purposes.
- Affiliate Systems web site.
- Promotion of events.
- Any other use related to the activity of FUTURTECNOLOGIAS.

FUTURTECNOLOGIAS shall not transfer the rights of use of the pictures, except for assignment of the model, to other companies belonging to the group.

The **artist** declares that all the photos provided to the platform, were taken when she was at least 18 years of age or older. (18 U.S.C. 2257 Record Keeping Requirements Compliance Statement)

It will be a matter of partial rejection of the high of the model:

- Photos of low quality.
- Photos in dimly lit or messy scenario.
- Non-artistic photos.

It will be a matter of **total and definitive rejection** of the model, without review:

- The use of photos that do not belong to the artist.

- The attempted use of photos of another person.

Important: The platform based his work in a high-quality, the photos provided by the artist must be of quality STUDIO/professional, at least before the 30 days after your discharge.

If the model does not provide photos of STUDIO/PROFESSIONAL at this time, the account will be suspended until the photos are provided.

5. DURING THE EMISSION STANDARDS

Express prohibitions

- You will **not be able to appear any person not registered in front of the webcam**, during the broadcasts.
- **The artist will not be able to eat or drink alcoholic beverages** during the broadcast.
- **Smoking is not allowed during the broadcast**, except at the request of the user.
- **Is not permitted in any case, the use of any narcotic substance.** This point will be the reason immediately of the artist.
- **The artist, you should not leave alone the issue in "online".** You can only leave the scene, meeting in private, at the request of a user of a garment or plug-in for the show.
- It is not allowed to perform actions in public or private chat, that are contrary to the legal system.

And expressly stated, **are completely prohibited the following practices:**

Sexual activity of minors, bestiality, incest, demonstration of blood or of animals and the imitation of the above is against the rules.

Role-playing games, including a role of minor is against the rules.

Any attempt to show text material to be a celebrity, offensive, suggest paedophilia, adolescence, bestiality or zoophilia, referring to elimination or consumption of bodily waste or involve words that are unacceptable by the standards of good taste will lead to the immediate and permanent suspension of the account in question.

- **Carry Out ADVERTISING FROM OTHER WEB SITES OR SERVICES**, is not permitted.
- **The use of the telephone** during the broadcast, is not permitted.
- **Sleeping during the broadcast**, is not allowed.
- **The emission of a still image or pre-recorded video**, will lead to the definitive cancellation and cancellation of any winnings accumulated in your account.

- **Giving and asking for personal information**, including personal information of visitors/members and models is against the terms of use.

The e-mail addresses from outside of the web sites, online messaging IDs (such as: Yahoo! , MSN, ICQ, etc.) permanent addresses , social accounts (Facebook , Twitter , LinkedIn) , etc. are considered personal information.

Any type of personal contact with visitors/members of the site, request escort service, prostitution or ask for money is strictly prohibited and is considered prostitution.

- **Give personal information of other artists of the platform or contact details, or speak in a derogatory way of other artists**, is not acceptable.

These rules **are not exclusive** of any other that, in future, be considered illegal.

These rules will be updated each time and shall be binding on the part of the artist.

6. REQUIREMENTS OF THE EMISSION

- The issuance must be made from a quiet place. Room with neutral decor and orderly manner.
- Good Quality Lighting, so as to avoid the shadows during the broadcast.
- The webcam used for emissions must be in any case brand Logitech, 920c or higher. Will the model issued the first two weeks with the Logitech C270 HD.
- The connection must have a minimum increase of 1 MB, preferably should be issue with optical fiber. Is not permitted the connection by wifi, in any case, the artist must be connected by cable.
- The artist should always issue with bedding or clothing, washed and combed properly.
- The artist must always maintain a cordial with users in any form of chat. It is not allowed to insult or abuse to the users.

The artist may report any lack of a user, from the support option in your profile. The support team will take the appropriate measures.

7. SANCTIONS

The FUTURTECNOLOGIAS team reserves the right to qualify the faults according to their own criteria and to the studio of the specific case, in three categories:

Minor:

A first notice to the artist to avoid the behavior considered as minor offense again.

Some examples of misdemeanor: eating, drinking, smoking or leave the room alone for a few minutes.

Serious Misconduct:

It is considered a serious offense, the consecutive realisation of two minor offenses.

The realization of a serious offense will lead to an economic sanction for the ARTIST, deducted in each lack a serious amount of 50 credits for their total accumulated in the period.

Some examples of serious misconduct: committing a number of repeated minor offenses, upload photos of profile that does not belong to the model, record videos with people not registered for the profile.

It is a very serious:

It is considered a very serious, a row of three serious faults. The realization of a VERY SERIOUS will mean an economic sanction or, in response to the severity, the low end of the platform and its ban on re-entry.

Some examples of very serious: commit three serious offenses, share personal data with a user, try to stay with a user, any practices contrary to the legal system.

Will always be considered very serious, the exposure of a child in front of the webcam.

Considered as a minor, any person that this issue has not reached at least 18 years and 21 years in other territories.

This behavior, it is not only a matter of closure of the account, but his complaint to the competent authorities of the country of origin of the artist.

8. EXEMPTION OF RESPONSIBILITY

FUTURTECNOLOGIAS shall in no case responsible for the misuse on the part of the artist of the platform.

FUTURTECNOLOGIAS is totally exempt from any liability with regard to the provision of the service on the part of the model, as well as the possible technical problems that do not depend on **FUTURTECNOLOGIAS**.

The **artist**, you will be obliged to pay **FUTURTECNOLOGIAS** any expense arising from misuse or misconduct in the provision of the service, leading to legal cause against **FUTURTECNOLOGIAS OR ANY OF ITS AFFILIATES**, because of this.

The use of illegal form of the platform, attempted fraud, or any other action on the part of the artist, will result in immediate account low with the freezing of funds and to his complaint to the competent authorities in their country of origin.

9. APPLICABLE JURISDICTION AND OFFICIAL LANGUAGE

These conditions have been drafted in Spanish, the official language of reference, any discrepancy on the same, shall be referred to the original version in spanish.

In any case, the artist declares that it renounces its jurisdiction of origin, subject in all cases to the jurisdiction of the Courts of Toledo.

To register as an artist, are tacitly accepted and irrevocable contractual conditions.

These conditions may be changed unilaterally by FUTURTECNOLOGIAS and notified 15 days prior to its entry into force, during which time they will be final.
